Kia ora Privacy

I refer to your Official Information Act (OIA) request of 25 June 2021 for:

“Under the Official Information Act, could I please request a copy of the all of the correspondence that the Climate Change Commission sent to their consultant Whetu Trading Trust, since the inception of the Commission.”

As you know, on 1 July 2021, the Climate Change Commission (the Commission) emailed you, requesting that you clarify or refine your OIA request. On 5 July 2021 you responded, refining your OIA request as follows:

“Under the Official Information Act, could I please request a copy of the all of the documents that the Climate Change Commission sent to their consultant Whetu Trading Trust, which is related to Te Ao Maori, the Treaty of Waitangi, Tikanga Maori or any other Maori related topics, since the inception of the Commission.”

The table below sets out the information within scope of this request and the rationale for any withholdings or refusals under sections 9(2) and 18 of the OIA. Please note that calendar invites and administrative discussions relating to scheduling meetings have been treated as out of scope of this request.

As you are aware, the CCC have initiated working with the Treasury (i.e., with s 9(2)(a) in an effort to maximise output in this Māori climate change space, given the time restraints we are all under. The key objectives we share include:

- building the knowledge base/data repository on Māori perspectives on climate change including mitigation pathways, impacts, and adaptation plans
- capturing a whakaaro Māori view on the framing and improve our knowledge of mātauranga and how/where this localised knowledge can be incorporated into the modelling, analytics, and advice.
- building out He Ara Waiora

s 9(2)(a) and I had a planning session on Tuesday and have scoped out a work plan. Within that there is a piece we would like Whetū to contribute to.

1. Through interviews and a desktop evaluations of iwi/hapū strategies, taiao strategies etc., collate insights that help populate the four dimensions under the Ira Tangata realm in He Ara Waiora <https://ir.canterbury.ac.nz/handle/10092/17576> which include:
 - Mana Tuku Iho—identity
 - Mana Āheinga—aspiration and capability
 - Mana Tauutuutu—community belonging and cohesion
 - Mana Whanake—prosperity
2. Draft a report, drawing on iwi/hapū/whānau organisation climate change long-term or Taiao strategies, submissions to PCE/MfE/MPI/MBIE/ICCC, etc, that addresses the following:
 - Context of this work re HAW
 - Explanations of Te Taiao, mātauranga, concepts of balance and wellbeing as pertaining to climate change
 - What are whānau, hapū, iwi aspirations?
 - What are the identified impacts of climate change?
 - What are barriers and constraints, and opportunities?
 - What are their adaptation plans and mitigation pathways?
3. Summarise interviews
4. Populate spreadsheet to link source documents, and summarise findings

I think you've already done some of this work, it will probably be a matter of repurposing existing information.

Will discuss in more detail tomorrow, also I'll provide the spreadsheet template that we are working from.

FYI, I've talked with s 9(2)(a) from my team, he's in the process of conceptualising the Ira Tangata aspect of HAW. So the next steps for me, after this think piece is complete, is to build on his thinking, and unpack that (along with other aspects of HAW) and develop all of it into a practical HAW tool for our analysts kicking off in June. If the Climate Commission would like to collaborate in that phase of the project (the developing and testing of this tool, and developing measures of success), please let me know. It would be neat to keep working together.

So just to be clear, the tracking sheet is basically an audit trail/high level summary of the mahi we are doing. It will later serve the purpose of making it's whakapapa, rationale etc. clear so we can easily communicate what we've done, and how we've aligned the work/insights/interviews etc. to He Ara Waiora and the CCC work.

In terms of what you've described below, are you thinking we change the scope of the mahi Whetū consultancy contribute, so we sub out the task involving populating the aspects of the Ira Tangata, and substitute with a focus on populating the 'means' to achieve wellbeing i.e., tikanga?

I'm happy either way, we really just need to lock it in with Whetū and make sure they have capacity to accommodate a change in scope, I'm assuming if it replaces one focus area with another then it should be ok, but I'll leave that to s 9(2)(a) to comment.

Thank you very much for this tracking template, s 9(2)(a) that's really useful.

In terms of unpacking He Ara Waiora, I think that the interim step is to look at how some of the key concepts underpinning HAW are expressed in the context of climate change (e.g. kaitiakitanga, kotahitanga, manaakitanga, tino rangatiratanga, whanaungatanga, tikanga). We can then explore how these fit into the wellbeing domains under Te Taiao and Ira Tāngata.

This is why I've proposed the approach below to the thinkpiece I'll be drafting, drawing on the mahi that s 9(2)(a) is doing in numbers 4 and 5.

1. What is a te ao Māori/mātauranga Māori view of wellbeing, in the context of HAW (I'd envisage this would include Te Orokohanga/ngā Atua, as well as mātauranga) - s 9(2)(a)
2. What is the context of climate change for te ao Māori s 9(2)(a)
 - The Māori economy
 - Māori land and asset ownership and governance

Te Tiriti and Deeds of Settlement

- (what else?)
- 3. How will climate change impact on whānau, hapū, iwi, and the Māori economy (where possible – this may be very high level or simple if we can't get Tupu)? s 9(2)(a) if we can get access to Tupu

Kia ora koutou.

You are receiving this email because you have been involved in the development of Climate Change Commission's work to understand impacts for iwi/Māori of different emissions reductions and removals options. I would like to thank you all for your contribution to the work to date, and am sending out this email to let you know where we are at in the process.

Throughout 2020 we engaged with you either kanohi ki te kanohi, on zoom, or over the phone to ask your whakaaro on impacts/potential impacts of climate change mitigation options. We did some supporting research, applied the [He Ara Waiora](#) framework (of which some of you contributed to) and incorporated your whakaaro to inform the Commission's first package of draft advice.

Our first package of draft advice will be released for public consultation on **1 February to 14 March 2021**. Our draft advice is contained in our **Advice Report** (outlining our key advice and recommendations), and is supported by an **Evidence Report** (summarising the analytics from each of the sector teams, including: Heat, Industry, & Power, Transport, Waste, Land Use, and Māori).

Because of the nature of our advice, we have to consider potential market impacts. This means we need to release our advice when financial markets are closed. For this reason, we will release our full draft advice report with its supporting evidence at **2pm, Sunday 31 January** on the [Commission's website](#).

At **9am on Monday 1 February**, our dedicated consultation website will be live and submissions can be made until 14 March.

We have attached our team's chapter from the draft Evidence Report, in-confidence, so you can see how your perspectives have been incorporated. We ask that you please don't distribute this chapter further before our formal consultation begins. We hope we have captured the majority of insights shared, however, if you shared perspectives and don't see them in the draft attached, they may be in other chapters of the Evidence report. For example, kōrero pertaining to whenua with old landfills which need to be restored are included in Waste chapter.

We would really like an opportunity to hear your feedback on how we have captured these insights and present the key aspects of our draft Advice Report during the consultation period (1 February – 14 March 2021) and would appreciate if you could make a written submission. We are happy to schedule some 1-2-1 or group chats during consultation. Could you please get in touch if you would like us to arrange a presentation either in person, if possible, or via zoom.

With regards to the Case Study materials, due to resourcing constraints we have put a hold on progress, however, will be picking these up again post-consultation and be in touch then.

Again, thank you all so much. We really would like to see this mahi help the Government seek out climate change solutions that lead to more equitable outcomes for iwi/Māori.

On behalf of He Pou a Rangi | the Climate Change Commission, we are pleased to present our final report www.climatecommission.govt.nz/inaia-tonu-nei-a-low-emissions-future-for-aotearoa which details our advice on transitioning to a thriving, climate-resilient and low emissions Aotearoa.

During our consultation phase, from 1 February 2021 to 28 March 2021, we held or attended around 200 meetings and events across Aotearoa and talked with an estimated 4,000 people. We also listened to tangata whenua, our Te Tiriti o Waitangi partners, to gather their perspectives.

Over 15,000 people made submissions through our website, through our Iwi/Māori 100CoastieVoices platform, through the post and by email. This response highlights that New Zealanders care about climate change. It also reflects our efforts to consult with, listen to and consider the voices of many thousands of New Zealanders who want to see a fair, inclusive and equitable transition for all.

We would like to thank all who participated in our case study research, 100CoastieVoices campaign and that met with us during consultations. We have attached for your information the summary report of findings based on responses received for the 100CoastieVoices submission process. Please note that all Iwi/Māori submissions will be released in late July (without personal information).

While there was overall support for addressing climate change challenges, Iwi/Māori submitters raised concerns that Māori would be disproportionately impacted by climate action if the Government does not uphold its commitments and obligations to Te Tiriti. We heard it is important to Iwi/Māori that government understands te ao Māori values and perspectives regarding taonga tuku iho and whenua, including land-use management constraints and appropriate decision-making processes.

We have included a new chapter in our final advice that highlights and addresses the key concerns raised by Iwi/Māori submissions. We have also emphasised and increased visibility of Te Tiriti throughout the report to create an opportunity for both Partners to strengthen the Crown-Māori relationship for the benefit of Aotearoa katoa, and to realise the benefits an equitable and enduring response to climate change will achieve.

This report is named Ināia tonu nei: a low emissions future for Aotearoa; advice to the New Zealand Government on its first three emissions budgets and direction for its emissions reduction plan 2021 - 2024. As the title suggests, Aotearoa needs to be proactive and courageous as it tackles the challenges the country will face in the years ahead. Aotearoa will need to ensure budgets and policies are ambitious and achievable, as the actions we take today will impact on the wellbeing of current and future generations.

The time is now, *Ināia tonu nei*, to lead the change we want to see and to remain steadfast to the values that underpin our nationhood—values like whanaungatanga, kaitiakitanga and manaakitanga. We recognise the power of being connected to each other, having an ethic of care, respect in the way we progress, and taking care of things for ourselves and our mokopuna.

Ināia tonu nei: the time is now for climate action

He Pou a Rangi Climate Change Commission has released its first independent advice to Government detailing ambitious, achievable and equitable paths Aotearoa can take to meet its climate targets.

The Commission's first advice *Ināia tonu nei*: a low emissions future for Aotearoa was tabled in Parliament today by the Minister of Climate Change.

Commission Chair Rod Carr says the advice shows a thriving, climate-resilient, and low emissions future for Aotearoa is possible - but the work must start now.

"*Ināia tonu nei* is a call to all of us to accelerate climate action today, not the day after tomorrow," he says.

Aotearoa has committed to reaching net zero emissions of long-lived greenhouse gases by 2050 and reducing biogenic methane emissions between 24-47% by 2050. The Commission's role is to provide independent, evidence-based advice to reach those targets.

The Government has until 31 December this year to consider the Commission's advice. By this date the Government must have set its emissions budgets and finalised the country's first emissions reduction plan detailing the policies it will use to achieve the budgets.

"Transformational and lasting change is both necessary and possible. The technology and the tools Aotearoa needs to reach its climate targets exist today. Our evidence shows climate action is affordable. *Ināia tonu nei* - the time is now.

"Current government policies do not put us on track to meet the Commission's recommended emissions budgets or the 2050 targets. As a country, we need to fundamentally change our response to climate change.

"Our advice reflects the position Aotearoa is in after years of short-term thinking and delay. Emissions will not reduce immediately - there is work to do first to lay the groundwork and the time to start that is now.

"Achieving the emissions reductions needed to get to 2050 will require elected officials to urgently build and sustain momentum to reduce emissions. We should not push the burden of addressing climate change onto young people and future generations."

The release follows a nationwide consultation on the Commission's draft advice held earlier this year. More than 15,000 submissions were received over this period.

"While views differed on what action should look like, how much the transition should cost, and what role Aotearoa has in the world, we have heard support across Aotearoa for decisive climate action and the momentum is growing.

"Evidence we received through consultation was used to test and refine our assumptions. Our judgements, conclusions and recommendations were also assessed and modified where appropriate in light of the material we received," Dr Carr says.

"It is now over to Government to decide whether to accept the advice, and to show how it will shape climate action in Aotearoa. Ināia tonu nei - the time for action is now."

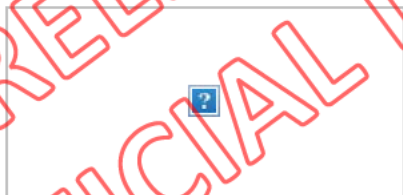
