Official Information Act request about submissions on the Climate Change Commission's Draft Advice

Tēnā koe Privacy

On 7 October 2021, the Hon James Shaw, Minister of Climate Change, transferred to the Climate Change Commission (Commission) your Official Information Act (OIA) request for response.

"I am asking you to investigate and respond to me and the public the nature and circumstances of the release of the first tranche of submissions in terms of their support or otherwise of the propositions of the CCC as compared to those now to be released under the OIA demand. How many submissions supported the CCC propositions and how many did not in each tranche released.

I also want to know under what circumstances decisions were made to release some submissions and hold back others? I want a copy of any correspondence internal or external at all levels in the CCC that relate in any way to the decisions taken to with hold submissions from the original release? I had understood that all submissions would be released.

Further as some submissions have not been released have they not been available to Members of Parliament who were making policy decisions based on the advice from the CCC?"

The response to your requests are set out below.

I am asking you to investigate and respond to me and the public the nature and circumstances of the release of the first tranche of submissions in terms of their support or otherwise of the propositions of the CCC as compared to those now to be released under the OIA demand. How many submissions supported the CCC propositions and how many did not in each tranche released.

The Commission received more than 15,400 submissions on the draft advice to Government we released for consultation on 1 February 2021. As can be expected from a large public consultation process, submitters' views were wide-ranging. Though some submitters supported or opposed the draft advice more or less in total, most submitters voiced agreement with some parts of the draft advice and questioned other parts.

Rather than attempting to quantify whether submitters supported or opposed the draft advice as a whole, the Commission read submissions and identified themes, for example, views on active transport, impacts of

transitioning to a low carbon economy, honouring Te Tiriti o Waitangi/The Treaty of Waitangi, etc. The extent to which submitters agreed, or did not agree, with the draft recommendations was not a factor in any decision on the release of submissions.

Where submitters provided feedback through the online portal, haveyoursay.climatechange.govt.nz, they were asked to respond to 30 different questions: questions on the "six big issues" and the specific recommendations in our draft advice. Each of these questions offered multiple-choice response options, as well as space for a textual response to be provided. I also want to know under what circumstances decisions were made to release some submissions and hold back others? I want a copy of any correspondence internal or external at all levels in the CCC that relate in any way to the decisions taken to with hold submissions from the original release? I had understood that all submissions would be released.

From the outset of the consultation process, the Commission intended to publish submissions. Due to the volume of submissions received, a progressive release approach was taken; the resources involved in publishing such a large number of submissions received in a variety of formats (via our online portal, email, post, etc.) was significant. The order of release was based on whether or not the submitter initially provided consent to publish when they made their submission.

On 29 March 2021, the Commission received a request under the OIA asking for all submissions. On 11 June 2021, the OIA requestor refined their request, confirming that they were only interested in submissions where consent had already been given to publish. The Commission prioritised the release of these requested submissions (see <u>OIA 2021-022</u>) and on 30 July 2021 released all but 269 submissions under the OIA.

As no requested submissions were withheld from this initial OIA release, I am refusing your request for information that relates to decisions to withhold submissions from the original release under section 18(e) of the OIA. This part of the OIA applies when agencies do not hold information within scope of a request.

All submissions except for one are now available online. The one unpublished submission was from an individual and was withheld under section 9(2)(ba)(i) of the OIA. In this case, I did not consider the public interest in this submission outweighed the grounds for withholding.

Further as some submissions have not been released have they not been available to Members of Parliament who were making policy decisions based on the advice from the CCC?

As government information, all submissions the Commission received are available to MPs upon request. Further, summaries of what we heard from submitters and through the consultation process can be found in Chapter 2 of *Ināia tonu nei: a low emissions future for Aotearoa*, which is available at: <u>https://ccc-production-media.s3.ap-southeast-2.amazonaws.com/public/Inaia-tonu-nei-a-low-emissions-future-for-Aotearoa.pdf</u>.

As you may know, the Government has announced that policy decisions on the country's first Emissions Reduction Plan are due to be made by 31 May 2022. This provides time for MPs to review submissions and further consider the Commission's advice presented in *Ināia tonu nei*.



Your submission on the Commission's draft Advice

In your email that accompanied this OIA request, you noted that you had given authority for your submission to be published. Your submission was incorrectly recorded in our system as not consenting to publishing and was therefore not released in the first tranche of submissions. I apologise for this administrative error, and I can confirm that regardless of when submissions were published, all submissions (including yours) were read and considered by the Commission prior to delivering our final Advice to Government.
