The Climate Change Commission has considered your request in accordance with the Act, and I can advise as follows.

Response

1. The total number of staff sent to courses run by wall walks in each of the last three years.

There were 67 Commission staff who voluntarily attended a Wall Walk one-day session, on 26 July 2023.

As above, the Commission has participated in one Wall Walk session only.

The session was known as Wall Walk.

4. The total amount spent on sending staff to Wall Walks courses over the last three years.

The cost of the Wall Walk session, in July 2023, for 67 Commission staff was \$5175, the ancillary costs are below.

As above, Commission staff have participated in only one event. Additional costs were as follows:

The Commission holds no information of any other funding provided to Wall Walk.

A staff Cultural Capability survey conducted at the Commission in 2021 showed that our people asked for help with having a better collective understanding of Māori-Crown relationships, among other things.

In 2023, the General Manager Governance and Corporate Services at the time, had participated in a Wall Walk course at a previous workplace and recommended it to the Commission as a cultural capability initiative to support the above feedback. See Document 1 for an email in this regard, please note that we have redacted personal contact details in reliance on section 9(2)(a) of the Act and do not consider there are any countervailing public interests in its release.

Staff participation was voluntary.

An invitation to participate was promoted on the Commission's intranet, on an opt-in basis. Staff were referred to Wall Walk's website for further information on the course content, <u>here</u>.

Please find attached the programme for the day at Document 2. However, we are advised that the topics covered in the session, Wall Walk promotional posters and course materials are subject to copyright and are the intellectual property of Wall Walk. As such, we rely on section 9(2)(b)(ii) of the Act to not provide this information as it would be likely to unreasonably prejudice Wall Walk's commercial position. We do not consider there are any countervailing public interests in its release.



9. Please provide emails, reports, messages or any other correspondence for any measurable outcomes from your agency attending Wall Walk courses.

A survey was conducted among staff who attended the day. Twenty-two people replied. The results are attached at Document 3.
