Official information request for information on interests of Climate Change Commissioners

Kia ora privacy

I refer to your request for information dated 11 May 2021, in which you requested the following information under the Official Information Act (OIA):

- Any documents seen or signed by the Chief Executive Officer, Ms. Jo Hendy, which refer to anything related to any conflicts of interest within the Climate Change Commission.
- Any documents seen or signed by the Chair of the Climate Change Commission, Dr. Rodrick Carr, which refer to anything related to any conflicts of interest within the Climate Change Commission.

Background

On 18 May 2021, in correspondence with the Commission, you clarified your request to information related to:

- interests of Commissioners, and
- interests declared during the appointment process, or which the Chair and/or the Chief Executive have been subsequently made aware of since the appointment of the Commissioners.

On 25 May 2021, the Commission informed you that it was transferring the portion of the second part of your request that relates to the appointment process to the Ministry for the Environment under section 14 of the OIA.

On 9 June 2021, the Commission extended the timeframe for responding to your request to 12 August 2021, under sections 15A(1)(a) and 15A(1)(b) of the OIA.

Response

The document schedule below lists the documents that fall within scope of this request. Please note, some information has been withheld under the following sections of the OIA:

- 9(2)(a) to protect the privacy of natural persons, including that of deceased natural persons;
- 9(2)(b)(ii) to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information







- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty
- 9(2)(h) to maintain legal professional privilege.

Some other information has been refused under s 18(d) of the OIA, as it is or will soon be publicly available.

Please note, Document 80 (email dated 10 May 2021, 3.53 pm - 9.47 pm), mischaracterised Commissioner Dr Judy Lawrence's concerns about her EDS-associated interest. Dr Lawrence was not asking to have her EDS-associated interest removed from the interest register. Rather, she wanted the nature of her interest to be corrected to make it clear that she is a member of and occasional donor to EDS but has never been the Chair.
