Official information request for documents sent to Motu on Maori-related topics

Kia ora **privacy**

I refer to your Official Information Act (OIA) request of 25 June 2021 for:

"Under the Official Information Act, could I please request a copy of the all of the correspondence that the Climate Change Commission sent to their consultant Motu, since the inception of the Commission."

As you know, on 1 July 2021, the Climate Change Commission (the Commission) emailed you, requesting that you clarify or refine your OIA request. On 5 July 2021 you responded, refining your OIA request as follows:

"Under the Official Information Act, could I please request a copy of the all of the documents that the Climate Change Commission sent to their consultant Motu, which is related to Te Ao Maori, the Treaty of Waitangi, Tikanga Maori or any other Maori related topics, since the inception of the Commission."

The table on the following page sets out the information within scope of this request and the rationale for any withholdings or refusals under sections 9(2) and 18 of the OIA. Some information has been withheld under the following sections of the OIA:

- 9(2)(a), to protect the privacy of individuals
- 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty.

Some information has also been withheld under section 18(d), as it is publicly available. Details of where it can be found are included in the table below. Please note that out-of-scope information has not been released and that calendar invites and administrative discussions relating to scheduling meetings have been treated as out of scope of this request.



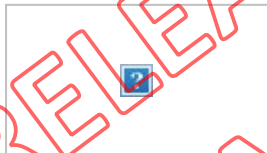

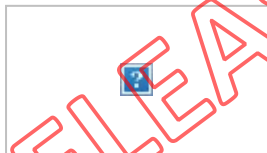

Kia ora tātou

I've been mulling this enquiry over and just had a chat with s 9(2)(a) on the phone. She was off-site so the conversation was short.

I asked s 9(2)(a) what her main concerns were and she responded that she would like to see better engagement with urban Māori in the Tamaki Makaurau rohe, regarding policy changes, urban design, RMA etc.

I explained to s 9(2)(a) that our current work is mainly focused on identifying mitigation options in the sectors with the highest emissions outputs including, Land use and waste, HIP, and Transport. I suggested that the key area of our current work that most likely aligns with the interests of the Independent Māori Statutory Board (IMSB) would be transport and later urban design.

Based on our korero, s 9(2)(a) is happy to connect with s 9(2)(a). We didn't go into funding, s 9(2)(g)(i)

I think the main take away for us is that our models need to factor in Māori population and

location data (noting that a lot of Māori don't complete census surveys so likely these numbers will be understated) and other data sets as they pertain to Māori e.g., household income, deprivation index etc., to help us understand equity impacts of the relevant mitigation options.
s 9(2)(a) and I are working through this.

If you're happy with that Rod, we can progress the relationship via their CE for now and escalate it upwards at a later stage if required. I'll keep you posted if anything further comes up.

align with the National adaptation plan. However, I think the appropriate place to do this will be in the final Māori sector report.

With regard to this report, it is absolutely our intention that it will pick up on impacts for iwi/Māori communities. We are aware that “Māori-collectives” covers a broad spectrum i.e., some Māori-collectives are really connected and supportive of their hapū, marae, and whānau, others are not, some Māori-collectives operate in accordance with their whakapapa and tikanga, others do not. When we talk about impacts the sorts of things we are thinking about include:

- Cultural impacts - how our cultural vitality and how cultural values will be protected? can we continue to travel to practice ahi kā? will different pathways impact on our tino rangatiratanga, mana motuhake, kaitiaki obligations? etc.
- Social impacts - what will different mitigation pathways mean for our people? Will we be able to remain socially connected? how it will impact household income, jobs, education, etc? will future pathways continue to force our people into low-paid labour, or will there be better opportunities to address inequity issues? etc.,
- Environmental impacts – what will these pathways mean for our whenua? how do we practice kaitiakitanga? what could be the impacts on our taonga tuku iho, our whenua, moana, awa, maunga? etc.,
- Economic impacts – how will different pathways impact on Māori economic resilience? Will they compound historic grievances, will they create further inequities/impediments to iwi/Māori economic prosperity?

A lot of these questions can be answered when we go back to the whenua (hence our case studies will include Māori land trusts). Through our whakapapa we can trace our iwi, hapū, whānau, marae, and whenua. When we talk about iwi/Māori communities in most cases (some exceptions including urban Māori) we are talking about all these things, as they are intrinsically linked. The Logic Mapping and Benefits Mapping exercises will help us clarify and communicate these relationships and identify the key impacts and which policy recommendations/levers will most effective. In saying that I think you raise a good point, which is to ensure we are drawing a good balance of insights from whenua based Māori-collectives, but also those that represent leadership for whānau Māori such as iwi, hapū, and marae.

I think it's also helpful to keep in mind that this report is simply part of our due diligence process and will enable us to base our recommendations on good quality evidence and information. As mentioned above, we are also working with the modelling team to make sure we can identify impacts based on socio economic groups, regions, economic sectors, jobs etc. We are confident that the DIM model will help tell a part of the story for iwi/Māori, however, there are gaps which this “Māori-collectives and Emissions Reductions” report will help us address. (**Note:** this is a terrible working title but we will improve it once we've had a bit more time to reflect).

All of these work streams will come together in the final Māori Sector report (also requires a better name) to provide a more comprehensive picture of how our emissions reductions plans and recommendations will include iwi/Māori with regard to impacts and solutions.

5M Matters Commission must consider

In performing its functions and duties and exercising its powers under this Act, the Commission must consider, where relevant,—

- (a) current available scientific knowledge; and
- (b) existing technology and anticipated technological developments, including the costs and benefits of early adoption of these in New Zealand; and
- (c) the likely economic effects; and
- (d) social, cultural, environmental, and ecological circumstances, including differences between sectors and regions; and
- (e) the distribution of benefits, costs, and risks between generations; and
- (f) the Crown-Māori relationship, te ao Māori (as defined in [section 5H\(2\)](#)), and specific effects on iwi and Māori; and
- (g) responses to climate change taken or planned by parties to the Paris Agreement or to the Convention.

5ZA Commission to advise Minister

(1) The Commission must advise the Minister on the following matters relevant to setting an emissions budget:

- (a) the recommended quantity of emissions that will be permitted in each emissions budget period; and
- (b) the rules that will apply to measure progress towards meeting emissions budgets and the 2050 target; and
- (c) how the emissions budgets, and ultimately the 2050 target, may realistically be met, including by pricing and policy methods; and
- (d) the proportions of an emissions budget that will be met by domestic emissions reductions and domestic removals, and the amount by which emissions of each greenhouse gas should be reduced to meet the relevant emissions budget and the 2050 target; and
- (e) the appropriate limit on offshore mitigation that may be used to meet an emissions budget, and an explanation of the circumstances that justify the use of offshore mitigation (see [section 5Z](#)).

(2) In preparing advice for the Minister under subsection (1), the Commission must have regard to the matters set out in [section 5ZC](#).

5ZC Matters relevant to advising on, and setting, emissions budgets

(2) The Commission and the Minister must—

(a) have particular regard to how the emissions budget and 2050 target may realistically be met, including consideration of—


- (i) the key opportunities for emissions reductions and removals in New Zealand; and
- (ii) the principal risks and uncertainties associated with emissions reductions and removals; and

(b) have regard to the following matters:

- (i) the emission and removal of greenhouse gases projected for the emissions budget period:
- (ii) a broad range of domestic and international scientific advice:
- (iii) existing technology and anticipated technological developments, including the costs and benefits of early adoption of these in New Zealand:
- (iv) the need for emissions budgets that are ambitious but likely to be technically and economically achievable:
- (v) the results of public consultation on an emissions budget:
- (vi) the likely impact of actions taken to achieve an emissions budget and the 2050 target, including on the ability to adapt to climate change:
- (vii) the distribution of those impacts across the regions and communities of New Zealand, and from generation to generation:
- (viii) economic circumstances and the likely impact of the Minister's decision on taxation, public spending, and public borrowing:
