The Waingawa Land Company is in fact a partnership, not a limited liability company, so technically we are partners not shareholders and there are no directors, just partners. It matters because if you search the companies register you will not find Waingawa Land Company.

Waingawa Forest Corporation Ltd is a registered limited liability company with directors and shareholders as disclosed. So a search of the companies register will reveal that entity.

As noted the Contact Energy shares, Auckland International Airport and Wellington Drive Technology shares are all sold and are no longer an interest.

The NZU sale is being progressed but as yet I have not received confirmation of the actual sale.

In the standing interest register in relation to a family member holding NZUS, you refer to me as Professor Carr, not so just Dr. Carr. Should we reveal it as my brother rather than a family member which could imply a spouse or child which would be a closer relationship? I am ok saying it is my brother.





What I'm trying to find out is whether you have an active role in terms of representing the Party or not as this will influence what we say to the Public Service Commissioner, who as you know, the Minister has suggested we notify about this interest. For example are

you involved in political campaigning for the Green Party, do you speak on their behalf, do you make political statements publicly or fund-raise for the Party etc? Or even if the answer to any of these is 'yes', do you intend to keep doing so? Sorry I know this questioning is intrusive so, if you'd rather not say, then I respect that. I'm just trying to anticipate what the Public Service Commissioner might say when notified and how we respond to that. I'd imagine from looking at the Code of Conduct for Crown Entity Board Members that a 'passive' membership may well be considered differently than an 'active' membership, if that helps. The wording from the Code in relation to political impartiality is as follows:

"We are politically impartial We act in a politically impartial manner. Irrespective of our political interests, we conduct ourselves in a way that enables us to act effectively under current and future governments. We do not make political statements or engage in political activity in relation to the functions of the Crown entity. When acting in our private capacity, we avoid any political activity that could jeopardise our ability to perform our role or which could erode the public's trust in the entity. We discuss with the Chair any proposal to make political comment or to undertake any significant political activity."

Tēnā koe Peter,

On 18 March 2021 we received from our monitoring agency, the Ministry for the Environment, the Code of Conduct for Crown Entity Board Members that you recently released. The release of the Code of Conduct coincides with work we are doing to ensure interests disclosure and permissions meet the requirements of the Crown Entities Act as well as guidance released by the Auditor General in June 2020. That has led to extensive disclosure by the Commission's Board members and I would like to bring to your attention one of those interests, and seek any guidance from you that you consider appropriate in managing this interest.

The interest concerns Professor James Renwick's membership of the Green Party of Actearoa which he has held since 2005, some 14 years before his appointment to the Climate Change Commission. Professor Renwick states that his involvement in the Party is limited to paying an annual membership subscription. He further states that he has never made any statements or campaigned on the Party's behalf. Given this I am satisfied, subject to your guidance, that this interest does not restrict Professor Renwick's ability to conduct his duties as a Climate Change Commissioner and, given his expertise in climate science, it is in the public interest for him to be able to do so.

However I am imposing, again subject to your guidance, two conditions on this interest. The first is that this interest is to be specifically notified to all Board members so that Board discussions are fully informed. The second condition is that Professor Renwick discuss with me any proposal to make political comment or undertake any significant political activity before doing so.

Please let me know you if you support the approach outlined above or what, if any, different or additional actions you think ought to be considered.

On 18 March 2021 we received from our monitoring agency, the Ministry for the Environment, the Code of Conduct for Crown Entity Board Members that you recently released. The release of the Code of Conduct coincides with work we are doing to ensure interests disclosure and permissions meet the requirements of the Crown Entities Act as well as guidance released by the Auditor General in tune 2020. That has led to extensive disclosure by the Commission's Board members and I would like to bring to your attention one of those interests and seek any guidance from you that you consider appropriate in managing this interest.

The interest concerns Professor James Renwick's membership of the Green Party of Aotearoa which he has held since 2005, some 14 years before his appointment to the Climate Change Commission. Professor Renwick states that his involvement in the Party is limited to paying an annual membership subscription. He further states that he has never made any statements or campaigned on the Party's behalf. Given this I am satisfied, subject to your guidance, that this interest does not restrict Professor Renwick's ability to conduct his duties as a Climate Change Commissioner and, given his expertise in climate science, it is in the public interest for him to be able to do so.

However, I am imposing, again subject to your guidance, two conditions on this interest. The first is that this interest is to be specifically notified to all Board members so that Board discussions are fully informed. The second condition is that Professor Renwick discuss with me any proposal to make political comment or undertake any significant political activity before doing so.

Please let me know you if you support the approach outlined above or what, if any, different or additional actions you think ought to be considered.

Thank you for your query regarding a disclosure made by a Climate Change Commission Board member through the Board's conflict of interest process. You have asked for guidance on appropriately managing a member's declared membership of the Green Party of Aotearoa.

As you are aware, managing any actual or perceived conflict of interest eventuating from a disclosure is a matter for you as Chair to work through with the member.

It is important to note that Board members have the same rights to freedom of speech and political activity in their private lives as other New Zealanders. Whether a particular political interest or activity might impact on a work role, and whether it can be managed, may depend on the:

seniority of the role

- nature of the role
- visibility of the political activity
- substance of the political activity.

The Office of the Auditor-General, in <u>Managing conflicts of interest: A guide for the public sector</u>, states that general personal factors such as political leanings will not usually constitute predetermination, unless they give rise to a strongly held personal belief that directly relates to the matter being considered.

We note that the level of political involvement disclosed in this situation does not extend beyond paying an annual subscription. The member has also stated he has never made any statements or campaigned on the Party's behalf.

You have said that you intend to impose two conditions on the disclosed interest. The first is that the interest is to be specifically notified to all Board members. We would advise that disclosure of this information to the Board should be treated consistently with any other actual, potential or perceived conflicts of interest that have been notified by all members. That is, we do not see the need to

The second is that the member discuss with you, proposals, if any, to make political comment or undertake any significant political activity before doing so. In our view you may not need to impose this as a separate condition as this requirement is already contained in the Code of Conduct for Crown Entity Board Members, with which all members need to comply.

Disclosure of conflicts of interest is a continuous process as interests change and new conflicts may emerge in the course of day-to-day business. The disclosure should be recorded on the Board's conflict of interest register and the member should update you if the interest changes?

If the interest changes you would need to consider if an additional course of action needs to be taken and how it would be documented.


