
Q5 What is your age?


Q6 In which region of Tauranga Moana do you live?






Q9 How well do you think your marae, hapū, iwi or hāpori will adapt on its own from challenges caused by climate change?












Q17 Do you support methane vaccines to help reduce biogenic methane emissions from dairy cows?






Q20 Will your business and employment prospects be impacted by the government's plans to move to a low emissions Aotearoa?




